



### WAY FORWARD FOR TADING GEWOG

This is to notify the general public that based on the epidemiological risk assessment of the presence of virus in the community and recommendation of the Technical Advisory Group (TAG) of Ministry of Health, the following risk categorization of the Chiowgs under Tading Gewog has been carried out. The following measures shall be implemented based on the risk categorization until further notice.

The targeted testing (comorbid and symptomatic individual) of the red cluster/community will be carried out on March 14, 2022 and further relaxation shall be notified based on the result of the testing.

### THE FOLLOWING CONDITION SHALL APPLY TO YELLOW AREAS

- Movement of people within the Chiwog shall be allowed. However no inter-Chiwog movement and movement to red cluster/community shall be allowed.
- Transport of agricultural and livestock products shall be facilitated through use of identified vehicles and drivers operating under containment mode.

### THE FOLLOWING CONDITIONS SHALL APPLY TO RED AREAS

- Livestock and farming activities shall be allowed within their premises without mixing with the neighbours.

### THE FOLLOWING CONDITIONS SHALL APPLY TO BOTH YELLOW AND RED AREAS

- All offices and schools shall remain closed.
- All shops and businesses shall remain closed.
- Mass gathering shall NOT be allowed (*ritual, rimdros, ceremonies*).





- Games and sporting activities shall NOT be allowed.
- Inter-Gewog movement shall NOT be allowed.
- No movement of vehicles are allowed, unless authorized for essential purpose.
- All health related incidents will be attended to and their movement will be facilitated.
- Construction activities and crushing units shall be allowed under strict containment mode upon approval by the DC19TF Monitoring and Inspection Team.
- Funeral rites shall be limited to close family circles not exceeding **20 people** with prior approval from the DC19TF.

All are requested to follow COVID-19 safety protocols (use of face mask, hand washing, practice physical distancing) at all times. The DC19TF solicits the continued cooperation and support of the general public during this difficult period.
