Notification on Relaxation of Tashicholing Gewog

This is to notify the general public that based on the outcome of cluster testing of Tashicholing Gewog conducted on March 12, 2022 and upon the recommendation of the Technical advisory Group (TAG) of Ministry of Health, the following relaxation shall be in effect for Tashicholing Gewog from March 16-27, 2022.

March 16 to March 27

1. Movement

- Inter-Chiwog movement shall be allowed.
- The movement timing shall be from **8:00 AM to 7:00 PM**
- Inter-Gewog movement shall **NOT** be allowed.
- **NO** movement shall be allowed from Red Houses/cluster.
- **NO** movement of vehicles are allowed, unless authorized for essential purposes.
- Medical emergencies shall be attended to and their movement will be facilitated upon verification by concerned health personnel.

2. Office/School

- Offices and schools shall operate under **WORK FROM HOME** mode as notified by RCSC.

3. Shops/Business

- Except bar, snooker, beauty parlour and salon, all other shops and businesses shall be allowed to open.
- Restaurant shall be allowed to open on take-away basis only.
- The shop opening timing shall be from **8:00 AM to 7:00 PM**.



- Shopkeepers and helpers with flu like symptoms shall come forward for testing and shall not attend to the shops.

4. Essential supplies

- Home delivery of essential supplies to Red Houses/cluster shall be carried out by the Gewog Essential Delivery Team. Requisition for essential supplies shall be placed at **17952968/17617571** from **9:00 AM to 12:00 Noon**.
- Transport of livestock and agriculture products shall be facilitated with e-movement pass.
- Transport of essential items to and from Samtse Throm shall be facilitated with e-movement pass on **Tuesdays, Thursdays and Saturdays** only.

5. Industries and Construction Activities

- Construction activities and industries shall be allowed to operate under containment mode with prior approval from the DC19TF.
- Transport of fuel and construction materials shall be facilitated with e-movement pass. The driver transporting the fuel and construction material must stay under containment.
- Restocking of boulders shall be allowed under containment mode only.

6. Import/Export

- Import of essential goods and construction materials shall be allowed on all days of the week except for Sunday.
- The entry of import vehicle shall be allowed up to 5:00 PM. However, it will be dependent on the availability of the parking spaces at ICP, Samtse.
- Export shall be allowed under containment mode with prior approval from DC19TF.

7. Public gathering/Social events


- **NO** public gathering (*ritual, rimdros, or other ceremonies*) shall be allowed.
- **NO** games and sporting activities shall be allowed.
- Funeral rites shall be limited to close family circles not exceeding **20 people** with prior approval from the DC19TF.
